- NO COURT FEES THE REST OF THE YEAR!
- BALL MACHINE INCLUDED  
UP TO 30 TIMES
- ONLY 10 SOLD FOR ENTIRE MEMBERSHIP
- VALID FOR 1 INDIVIDUAL ONLY  
NOT TRANSFERABLE WITH ANOTHER MEMBER
- COVERS YOUR PORTION OF COURT FEE  
OTHER PARTIES OF COURT RESPONSIBLE FOR THEIR PORTIONS OF COURT FEE
