TENNIS Individual Gold Court Pass: Only 20 available!

Every Gold Court Pass is sold to an individual and cannot be shared between members regardless of whether they share a family or mini-family membership. You must have a current membership to purchase a Gold Court Pass. Each court pass expires on September 30, 2024. Unused time will not carry over.

Membership Agreement

Facility usage

Memberships are non-transferable and non-refundable. Court time, lessons, programming, and other expenses are separate and are not covered by membership dues. For Gold Court Pass holders, the allotted court time is covered by the court pass. For Gold Court Pass holders, lessons, programming, and other expenses are separate and are not covered by the Gold Court Pass. Pueblo Tennis Center rates and policies may change without prior notice. Management reserves the right to cancel a membership at any time.

Auto-Renewal

I, the undersigned, am taking out a membership at the Pueblo Tennis Center. I agree to pay my membership in accordance with the one-time Annual Membership payment option or the Three Payment option. I have read all of the Tennis Center's policies and regulations (located at www.pueblotenniscenter.info, and the waiver on this contract, and I agree to abide by them accordingly. I understand that tennis membership fees will be automatically renewed at the conclusion of each Annual Payment or Three Payment option. If I do not wish for my Annual Membership to renew automatically, I must notify club management in writing 650 a minimum of 30 days prior to the expiration of my Annual Membership.

Membership Termination/Freeze

I understand that any cancellations or changes made to my Annual Membership must be done so in writing. I understand that if I desire to freeze my Annual Membership during this contract period, I will be assessed a membership freeze fee of \$200.00, in order to qualify for pro-rated membership dues. Winter Months may be valued at a higher rate to Summer Months in pro-ration calculation. I understand that if I cancel my Annual Membership for any reason before the conclusion of this contract, I will be required to pay an early termination fee of \$300.00 in order to qualify for a pro-rated refund. I understand that if I make any other changes to my Annual Membership, I may be assessed a \$100.00 change fee to do so. I understand that if I cancel my Annual Membership for any reason, this will qualify as a lapse in Annual Membership, and I will be required to pay a current initiation fee if I decide to rejoin The Pueblo Tennis Center at a future date.

Fee Payments

I agree to pay my initiation fees in accordance with my membership choice. Initiation Fees apply when there is a lapse in membership. No Exceptions. ACH and Credit Card are required for Memberships. Annual Memberships are non-transferable and non-refundable. I agree to pay my membership in accordance with either the Annual Payment Option or the Three Payment Option. **I understand that this is an Annual Membership paid in 3 installments due the first three months when starting my membership; normally October 1, November 1, and December 1.**
